8. Action Items:

a. Discussion and possible action on Home Occupation Business License Application, Tiffany's Floral & More, Tiffany Jones

Tiffany Jones said I am interested in turning a hobby that I love into a small business. I like to make floral arrangements, boutonnieres and corsages. Quite often I will do something in silks so they can be keepsakes. Occasionally I will do something in fresh floral. I order fresh flowers and they are delivered by UPS. And I typically deliver them. Most orders are by phone and I deliver them usually to St George. I brought a couple of boutonnieres and a corsage for you to see.

Scott Messel said home occupations are allowed in the Town. Cottage Industry is encouraged. One of the biggest concerns is making sure that the residential property stays primarily residential.

Tiffany Jones said I will do the boutonnieres and corsages mostly for prom night and dances.

Commissioner Darton said if you are going to be doing mostly boutonnieres and corsages for dances and maybe wedding floral....

Tiffany Jones said wedding and maybe some funeral florals.

Commissioner Darton said are you going to be delivering?

Tiffany Jones said I will deliver.

Commissioner Darton said there will not be a lot of traffic coming to your home to pick up or anything?

Tiffany Jones said if I do corsages or something for a dance, I will try to get all of my kids' friends who want one all together and I will deliver them to the school.

Chairman Swenson said I have one question for Peggy. When she came in to apply did you give her any information or direction as far as what a home business would require? I mean, we do not have a floral business.

Peggy Rosebush said I discussed it with her. I told her that I thought, maybe, you might approve this floral business under crafts.

Chairman Swenson said and I would agree.

Scott Messel said if you determine it is more like a craft, you do not have people coming and there will not be a storefront, the impact is very minimal. It is a minor home occupation. Larger major home occupation businesses are handled as a conditional use. If you look at what the major home occupation businesses are, it is things like auto repair, commercial kennel, bed and breakfast. Everything that is listed under the major home occupation, Chapter 24.2.5.2, all of those have people coming to the residence. She will be delivering. The impact is minor.

Tiffany Jones said very seldom would I have an order like that unless it was a large wedding or something. Typically, I would go pick up the floral I need from a friend who is a florist.

Chairman Swenson said let me be the devil's advocate now. Let's say your business becomes very popular, and you like it, and all of a sudden you have another employee or two, and it is so busy that actually people want to pick up their order. So, you are going to grow. Now, how does that fit in? If you grow to the point you have a couple of employees and you are really busy certain times of the year, people are coming and going, do you know all of the parameters?

Tiffany Jones said I have a 10-year-old. My job and my desire are to be a full-time mom. I am not anticipating any of that happening for at least a decade and then it would probably happen very slowly. At that point, maybe I could come back and re-address issues with you. I just want to have this little hobby of mine be official and do it legally. For now, I want to enjoy it as a hobby.

Commissioner Rosenthal said I have one question. I do know that somewhere in our ordinances there is a condition for home businesses that the business does not occupy more that 25% of the square footage of the house.

Tiffany Jones said I have one little room, now that my son got married and moved out, that I have turned into my flower room and the rest of the house is lived in by my family.

Commissioner Hadley said the only question I have is "and more"?

Tiffany Jones said I do little home crafted gifts.

Commissioner Darton said unless anyone else has more questions, I would like to make a motion to approve the Home Occupation Business License for Tiffany's Floral & More. 2<sup>nd</sup> by Commissioner Rosenthal\_. All voted. Motion passed.
