Anahi Jaramillo said my family owns the Mexican restaurant. I have a question regarding the beer and wine license. My family would like to know what it is we need to do to obtain this license.

Mayor Peterson said you need to have a completed application. Your request will be put on the Planning Commission agenda. The next Commission meeting is on October 7<sup>th</sup> and then they will make a recommendation to the Town Council. The Town Council meeting following that will be Wednesday, October 14<sup>th</sup>. If you can come by Town Hall tomorrow or early next week, we can get that in place. Mayor Peterson said the changes to the budget are in 3-line items. There is a transfer from beginning fund balance of \$82,080, which is the Town's share of the Main Street Project, which was zero initially. There is a State grant which was also zero initially of \$259,920 and that is the UDOT funding for their share of the project. And on the expense side, we have line item Main Street Project which was zero initially of \$342,000. At this point, is there anybody from the public wishing to comment on the amended budget of 2020/2021? There were no comments.

## 11. Staff Reports:

Councilmember Roberts said I would like to remind individuals that there is an opt out period on recycling. I am not going to steer one way or another, but I will make a statement that any type of recycling generally will cost you more than disposing of things at the landfill. At some point, Washington County's landfill will be filled up at max and the intent is to push it out as long as we can by recycling things. There will not be another opt out period for individuals so make a choice now.

Mayor Peterson said I recently heard from Natalie Nelson informing me that the end of next week will be the end of her time with Washington County. The Commissioners have asked that, between now and then, she prepare an interlocal agreement related to the Silver Reef Museum and she will be looking to get that done working with Steven Scott ,the individual who has been identified as her replacement. That is the new information from Washington County.

Mayor Peterson gave a Covid report on education, Halloween and meetings at Town Halls in the County. Our Halloween event in Leeds will not happen in 2020. Hopefully, we can resume this activity in 2021. We will continue to postpone in person meetings at Leeds Town Hall until we get to green when gatherings will not be an issue.

# 12. Closed Meeting

Mayor Peterson said there is a Closed Meeting tonight relative to pending litigation. We are looking to meet in a closed session per Utah Code Section 52-4-205.
